

## **BANK FRAUD** FBI Announces *Operation Continued Action* Targeting Financial Institution Fraud

**Summary:** The Federal Bureau of Investigation (FBI) has published developments in a nationwide enforcement operation directed at organized groups and individuals engaged in financial institution fraud.

Thus far, these charges have resulted in more than 144 arrests, convictions and sentences, and millions of dollars in forfeiture and restitution.
